Financial Report:

Regrettably, the Treasurer Jo Taylor, resigned her position in March which has left the treasurers' position vacant. Therefore, this report is compiled by the Senior Vice President. Although small, the year ending 28 Feb 21 produced a \$6k profit.

Covid-19 has had a significant impact on revenue for the 20/21 financial year. The annual A & P show was limited to an equestrian event only [run by the MA&P] that returned a small profit of \$1.6k. The prize money for this event was paid electronically for the first time and proved to be acceptable by the competitors. This alleviated the need to withdraw and hold, substantial amounts of cash.

Audit Review Report

17 May 2021 - The reviewer, Mary Davis, reported on the annual accounts and found that in her opinion the financial records as displayed in the Financial Statement fairly reflects the financial position of the Manawatu & West Coast A & P Association (Inc).

NZ Dairy Event

With the relaxation of Covid-19 restrictions, the NZ Dairy Event was able to be held. The show was a resounding success and managed to record a profit of \$1.8k.

Office Manager

The employment of the Office Manager has proven to be very successful. The salary, annual and sick leave, IRD returns and time management is managed by Pay Source for a monthly subscription of \$35 per month. Oversight and support of the Office Manager is provided by the Senior Vice President.

Equipment

Equipment has been depreciated in accordance with current practices. Where there is a zero value of the equipment, these have been written-off but still appear on the asset register.

Other Income

This income is derived from Hireage of our equipment and horse measuring by John & Maren Wall. Our thanks to David Dench who continues to ensure that the equipment is maintained in good order and ready for Hireage or use by the A & P.

Financial Report:

Financial Report

The Treasurer's position has remained vacant, and all financial transactions have been accomplished by the Office Manager, Lisa Edgeworth with authorisations completed by Brad Powell (President); Bob Phillips (Senior Vice President) and Ash Hazlett (Executive Member). Therefore, this report is compiled by the Senior Vice President.

The year ending 28 Feb 22 produced a \$13.5k surplus which was double the previous year end but once again Covid-19 impacted the A & P Annual Show which regrettably had to be cancelled. This had a significant influence on revenue for the 21/22 financial year. However, an extremely successful NZ Dairy Event contributed to the ongoing financial viability of the Association.

Audit Review Report

26 April 2022 - The reviewer, Mary Davis, reported on the annual accounts and found that in her opinion the financial records as displayed in the Financial Statement fairly reflects the financial position of the Manawatu & West Coast A & P Association (Inc) as of 28 February 2022.

NZ Dairy Event

Despite the restrictions imposed by the Governments' Covid-19 traffic light system, the NZ Dairy Event (NZDE) went ahead and was a resounding success with entries up on the previous year. Grants to the value of \$14.5k and sponsorships of \$37.4k resulted in a surplus of \$15.5k.

Office Manager

Lisa Edgeworth worked hard to secure grants for the NZDE and assisted with the administration associated with the event. This position continues to be an essential role that enables the Association to function efficiently. Oversight and support of the Office Manager is provided by the Senior Vice President.

Equipment

I have performed an audit review on the Financial Statements attached that provide information about the financial performance of the Manawatu & West Coast A & P Association (Inc) for the year ended 28 February 2022 and its financial position as at that date.

I have obtained all the information and explanations I have required and my examination has not disclosed any unrecorded income or expenditure, but in common with other organisations of a similar nature, complete control is not practical and although I have no reason to think that there is any unrecorded income or expenditure, I am not able to confirm this.

In my opinion the financial records as displayed in the Financial Statement fairly reflects the financial position of the Manawatu & West Coast A & P Association (Inc) as at 28 February 2022 and the results of its operations and cash flows for the year ended on that date.

Manawatu & West Coast A&P Association (Inc.) Statement of Accounting Policies For the year Ended 29 Feb 2022

- 1 **Reporting Entity:** Manawatu and West Coast A&P Association (Inc.) is an incorporated Society and has therefore taken advantage of all differential reporting exemption.
- 2 Manawatu And west Coast A&P Association (Inc.) is a registered Charitable trust "CC34970" and reports annually to the Dep't of Internal Affairs Charities Services.

Measurement Base:

The accounting principles recognized as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by Manawatu & West Coast A&P Association (Inc.)

Specific Accounting Policies:

The following specific accounting policies which materially affect the measurement of financial performance and the financial position have been applied.

- a. Accounts receivable: Accounts Receivable are stated at their estimated net realisable value.
- b. **Fixed Assets & Depreciation:** Fixed Assets are stated at cost less aggregate depreciation. Depreciation has been calculated using the maximum rates permitted by the Income Tax Act 1994
- c. **Goods and services Tax**: The financial statements have been prepared on a GST exclusive basis.
- d. **Differential Reporting**: The entity qualifies for differential reporting as it is not publicly accountable and there is no separation between the owners and the governing body. The entity has taken full advantage of all differential reporting exemptions.
- e. Changes in Accounting Polices: Depreciation has not been charged on show plant and machinery as from 1 March 2004. All other deprecation has been applies as in previous years.
