SECTION POINTS PRIZE:

Competition means two or more entries. One entry is not a competition; half points only will be awarded. In the event of two exhibitors or more gaining equal points, the exhibitor gaining most first prizes will be declared the winner. If points are still equal, the exhibitor being awarded most Championships will be declared the winner.

Brucellosis Free Accreditation Certificates MUST be supplied with all Ram Entries.

By-Laws

1. All sheep must be entered in the name of a bona-fide owner, and other than those in commercial classes must be from registered flocks. Where the exhibitor is not the breeder, the name of the breeder must be stated on the entry form. Sheep shall be identified in accordance with the rules and regulations of the particular Breed Society with which the sheep are registered.
2. The giving of a prize to a sheep shall imply that the judges are satisfied that such sheep are fairly shorn and fairly presented.
3. **Definition of hogget:** A sheep born after **1st July** in any one year shall be considered a hogget up to and including **31st December** in the following year except in the case of the Dorset Horn and Poll Dorset sheep when **May 1st** should be substituted for **July 1st**.
4. Hogget's are eligible for championship judging unless otherwise stated.
5. Dry mixed aged ewes will not be eligible to compete for championship.
6. All sheep in shorn classes must be machine shorn on or after **20th July** in the current year and no

later than **28 days** before the date of the Show.

-with the exception of the Black and Coloured Sheep section where dates for shorn classes are- on or after 20th May

7. In purebred classes for a ewe and her suckling lamb, the lamb must be of the same breed as the ewe.
8. Championships will only be awarded where, in the opinion of the Judge, an animal is deemed worthy of the award.

JUDGING & PENNING ARRANGEMENTS

All sheep will be judged from 9.30am on Saturday 1st November.

Sheep must be penned by 8.30am sharp, ready for judging.

Departure time – Sheep must not be removed from the Pavilion until after 4.30pm on Saturday 1st November

Portable loading ramps will be available to assist with loading and unloading. These conditions will not be varied except in exceptional circumstances approved by the Chief Steward. When making transport arrangements, Exhibitors should take this into consideration as dispensation will not be given to suit particular transport arrangements.

GENERAL INFORMATION

- 1 Sheep entered in classes in pens of two or more cannot be entered in single entry classes, except where especially stated.
- 2 All entries in Purebred classes to be shown in full wool unless otherwise stated.
- 3 Exhibitors are reminded that the use of Bloom Dip or any artificial colouring is now covered by Government Regulations.

BY-LAWS APPLICABLE FOR THE SHEEP SECTION

Protests and Objections

- 30 The determination of a judge shall be final as between all competitors, unless an objection is made to any exhibit and allowed on the ground of disqualification.
- 31 Every objection or protest must be made in writing within one hour of the judging of the class in question, signed by the person making such complaint, and delivered to the Secretary. The Objector shall, at the time of making such objection, lodge the sum of \$40 dollars which shall be forfeited to the Association should the objection be considered frivolous or vexatious.
- 32 Notwithstanding anything contained in the above rule, the Controlling Body may cause an investigation to be made or demand an explanation concerning any matter, which in their opinion, is considered necessary, and may so enforce penalties, fines and forfeitures as is deemed expedient.
- 33 Protests and complaints against any exhibit must be made in writing. If lodged before judging is commenced, the onus of disproof will rest upon the person protesting. The Committee shall have power to refuse to entertain any protest or complaint lodged not later than the last day of the Show.
- 34 All protests, objections, and every matter in dispute, of whatever nature, by or between any person whatsoever, shall be determined by the Judicial Committee whose decision shall be absolutely final and binding on all parties, whether such dispute be between any person or persons and the Association.
- 35 The Chairperson of schedule committees or chief stewards shall have, at their discretion, power to decide any dispute in their respective divisions after consultation with the stewards of the section involved.

Prizes

- 36 All prize awards will be paid within two months of the Show.
- 37 The Association reserves the right to substitute trophies in lieu of cash prizes or vice versa at their discretion, and any dispute in connection with private prizes shall be settled by the Committee, whose decision shall be final.
- 38 In awarding championships, the Judges will select another animal to be called the "Reserve", to supplant the Champion in case of disqualification.
- 39 Reserve Champion to be selected from first and second prizes in respective divisions, and a certificate issued to the Reserve Champion.

- 40 If a prize winner be afterwards disqualified, the Committee may, with or without the advice of the Judge, decide whether the next animal on the list shall gain the prize.
- 41 The Association shall not be responsible or liable in case of any error, misstatement, or mis-description appearing in any Prize Schedule or Show Catalogue, or in any Form or Certificate of Entry, or in any advertisement or notification, whether posted, displayed or published.
- 42 All trophies will be presented at the discretion of the Committee. All trophies will become perpetual trophies as from the 1991 Show.
- 43 The Committee reserves the right to make any alteration in the Show time table, or to postpone the Show, or withdraw any event as may be deemed desirable

Conditions of Entry

- Shorn section, shearing date on or after 20th May
- Fleeces to be delivered to the Stadium ready for judging by 9am on Saturday 1st November 2025
- Fleeces must be suitably packed and properly labelled with exhibitor's name and class number.
- All fleeces are to be skirted and to be not more than 12 months growth.
- If insufficient entries in any class, then classes will be combined at the discretion of the Chief Steward i.e. mature fleeces of all microns
- Judged together as well as woolly hogget fleeces and shorn hogget fleeces.
- Fleeces may be picked up after 4.30pm on Saturday 1st November
- Exhibitors are responsible for the return of their own fleeces or the fleeces may be donated to the wool section.

Prize money 1st \$12, 2nd \$8, 3rd \$5, (5 entries or more).

Entry Fees: \$10 per entry

Special Prize: A Novice Champion Sash will be awarded to the exhibitor in their first three years of showing, who gains the highest points.

General Rules & Conditions

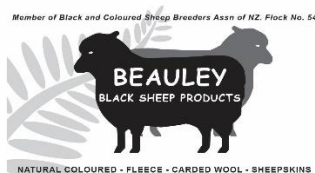

The Rules and Regulations as issued by the Royal Agricultural Society of New Zealand (Inc.) for the governance and conduct of A & P Shows have been adopted by the Manawatu & West Coast A&P Association. **It is the responsibility of exhibitors to be conversant with these rules.** Copies of the Rules and Regulations are available on request.
2. **Entries are accepted on the clear understanding that the Rules will be adhered to.**
3. **Disclaimer:**
 - By entering to compete at the Manawatu A&P Show, you are accepting and agreeing to abide by the Rules of the Royal Agricultural Society of NZ. and the Manawatu & West Coast A&P Association.
 - You are also indemnifying the Manawatu & West Coast A&P Association against damage(s) or injury occurring while you are on the showgrounds or its environs to participate in the Show.
 - The Manawatu A&P Association shall not be responsible for any loss or damage (inter alia) caused through disease or infection however arising. Each exhibitor shall be deemed to have guaranteed to the Manawatu A&P Association and have given warranty that to the best of their knowledge, each exhibit entered and brought to the showgrounds is free of any contagious or infectious disease.
4. Depending on entries at closing date, classes may be cancelled, split, or combined if appropriate.
5. The Manawatu A&P Association is required to conform to the **Health and Safety at Work Act 2015**; therefore you are required to carry out your work or undertaking on the Manfeild Park premises to comply with this Act. As a show exhibitor at this venue you are obligated to accept responsibility for ensuring a safe showing venue within the focus of the Act. As a user of these facilities, you are required to manage and supervise all your activities and live animal exhibits to ensure the good Health and Safety of all people involved in the show, at all times.

Health & Safety Specific Requirements:

- All vehicles, caravans and floats requiring power must have a Warrant of Electrical Fitness that meets legislation standard AS/NZS 3001.
 - Any and all electrical equipment, including extension power leads, must be tested and tagged with a current tag.(Standard AS/NZS3760)
6. **‘In-Line Resolution Process’ Policy:** This Show supports the RAS ‘In-Line Resolution Process’ Policy system. An explanation of the rules under This process can be found at Our Rules, Regulations and Policies – Royal Agricultural Society New Zealand (ras.org.nz)

7. The RAS Resolution Process can be found on the RAS website, as above. The principle behind the process is to deal with the matter as it comes to hand and in most cases it should be dealt with directly by the show. If the matter is in regards to a RAS official, the show may request the assistance of RAS Head Office as to how to deal with this in an appropriate manner.
8. The show would prefer that **dogs** are not brought onto the grounds; but if you do bring a dog it MUST be on a lead and controlled at all times. The car racing circuit and its environs are strictly out of bounds for dogs.
9. **Limitation on Entries**
The Committee reserves the right to limit entries. Exhibitors are directed to the conditions and by-laws. If any entry has to be refused, entry fees will be refunded in full.
10. **Drinking Utensils**
Drinking utensils will not be supplied for stock in the Sheep Section and exhibitors should bring suitable containers to the show. Exhibitors are also reminded that only town-supply water is available
